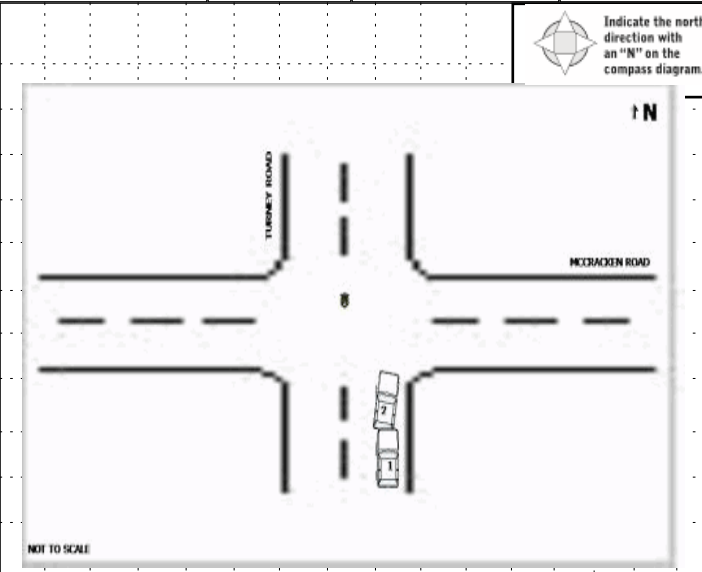

UNIT #1 AND UNIT #2 WERE BOTH TRAVELING N/B ON TURNEY ROAD (UNIT #1 IN OUTSIDE LANE AND UNIT #2 IN INSIDE LANE). AS UNIT #2 MOVED TO THE OUTSIDE LANE, THE OPERATOR OF UNIT #1 DID NOT LEAVE ENOUGH DISTANCE BETWEEN BOTH UNITS CAUSING THE FRONT OF UNIT #1 TO STRIKE THE REAR OF UNIT #2.

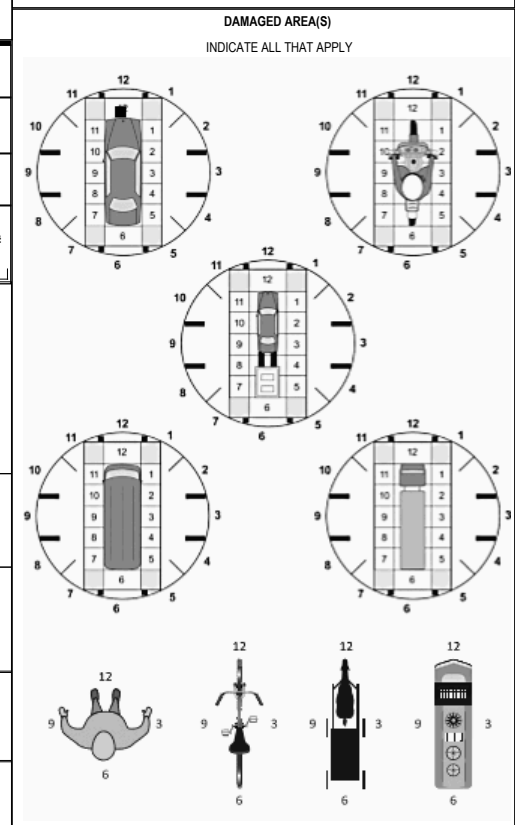
