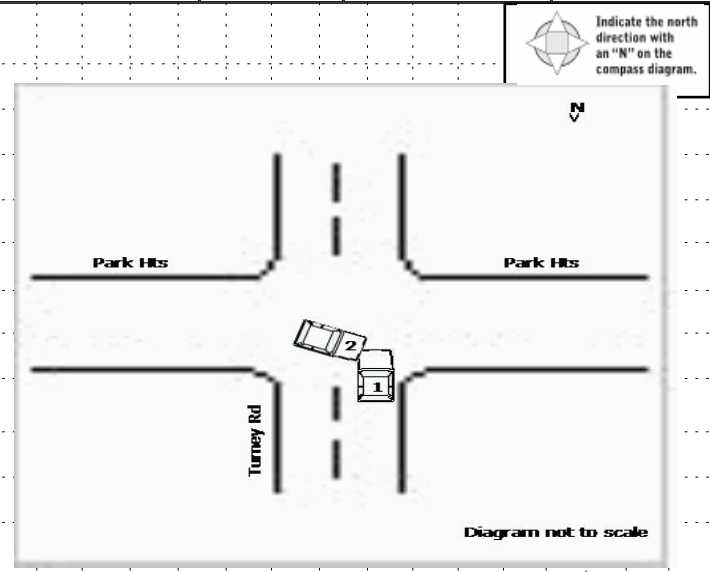

NARRATIVE

DRIVER OF UNIT 1 STATES HE WAS TRAVELING S/B ON TURNEY IN THE CURB LANE APPROACHING THE INTERSECTION AT PARK HTS. AS HE CONTINUED S/B UNIT 2 TURNED LEFT (W/B) CROSSING OVER THE LANE OF TRAVEL OF UNIT 1. AS A RESULT UNIT 1 WAS STRUCK BY UNIT 2. BOTH VEHICLES STOPPED AND THE DRIVER OF UNIT 2 EXITED HIS VEHICLE BRIEFLY, MADE A COMMENT, THEN RETURNED TO HIS VEHICLE AND FLED THE AREA W/B ON PARK HTS. DRIVER OF UNIT 2 WAS DESCRIBED AS A B/M WITH LONG DREADS WITH BROWN IN THEM AND POSSIBLY IN HIS MID 20'S. SEE ADDITIONAL

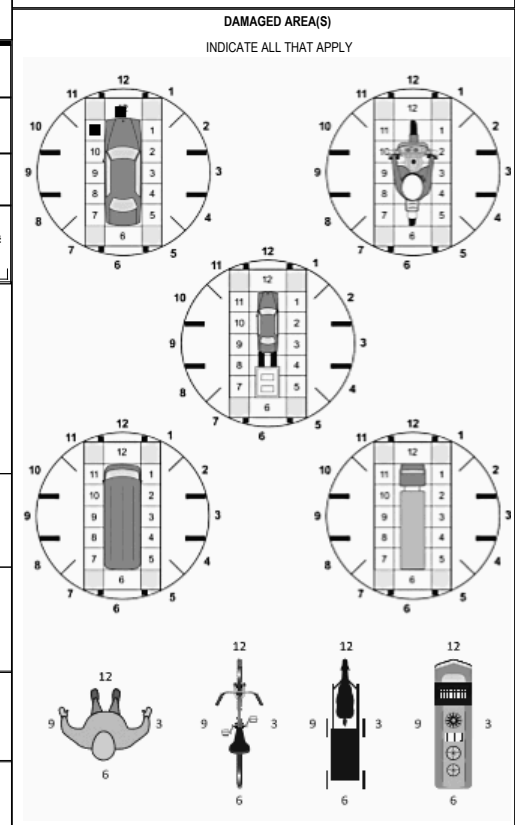

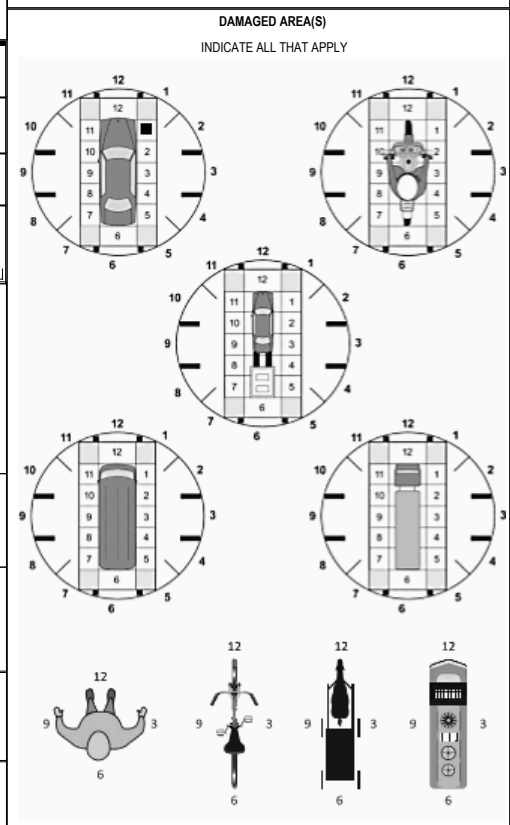
