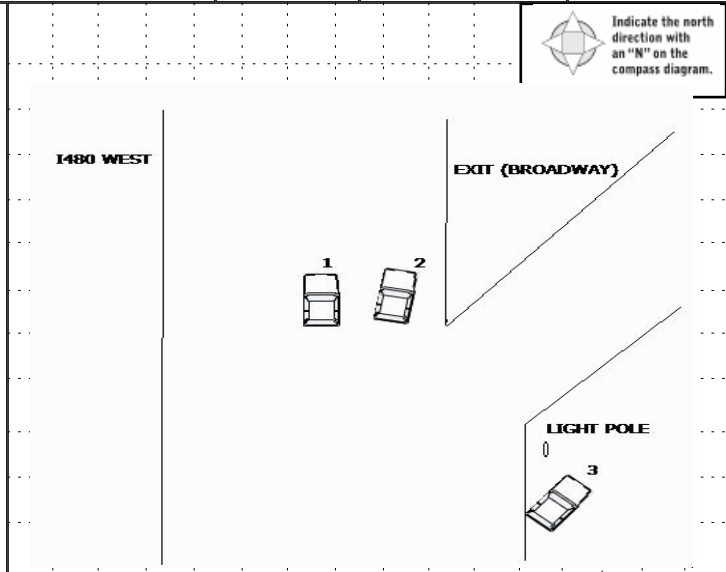

NARRATIVE

WITNESS STATE UNIT 1 AND 2 WERE RACING ALONG WITH A THIRD AUTO, A BLACK AUTO. WITNESS STATE THE BLACK AUTO KEEP TRAVELING W/B, ALL UNITS WERE TRAVELING AT AROUND 100MPH. UNIT 2 WAS TRAVELING FROM THE FAR LEFT LANE ATTEMPTING TO MAKE AN EXIT ONTO BROADWAY. TRAFFIC WAS HEAVY AND UNIT 1 STRUCK UNIT 3 THAT WAS TRAVELING IN THE CENTER LANE. UNIT 1 THEN LOST CONTROL AND RAN OFF THE ROADWAY TO THE RIGHT CROSSING THE EXIT RAMP STOPPING IN THE GRASS. UNIT 2 LOST CONTROL SLID RIGHT OFF THE ROADWAY AND STRUCK THE LIGHT POLE.

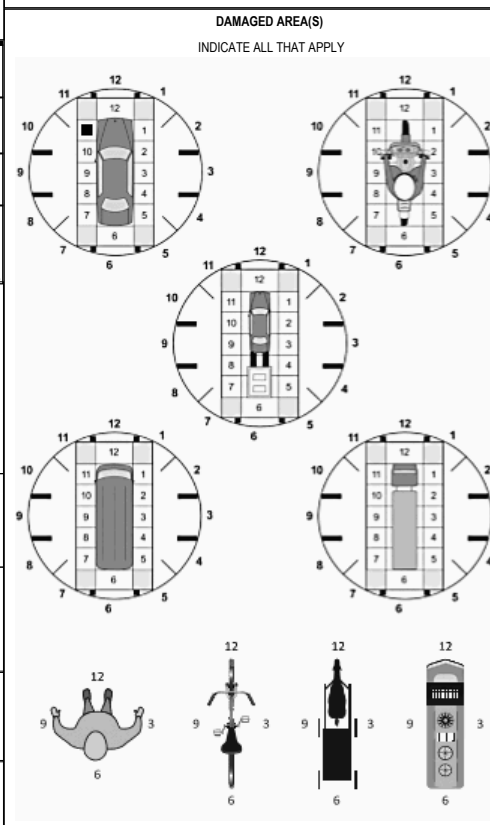

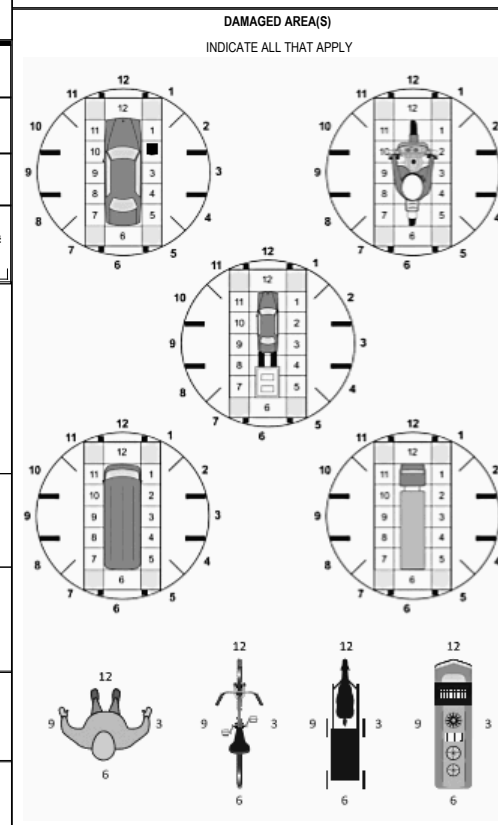
