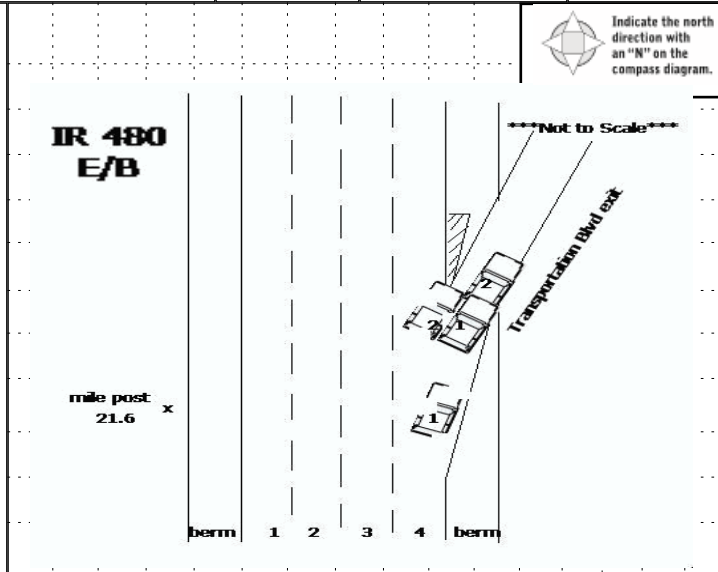

NARRATIVE  
 DRIVER OF UNIT 1 STATED HE WAS TRAVELING I-480 E/B AT MILE POST 21.6 AND WAS EXITING AT TRANSPORTATION. AS HE ENTERED THE EXIT RAMP LANE, HE NOTICED UNIT 2 SWERVE FROM LANE 4 TO THE RIGHT, STRIKE THE CRASH BARRIER AND GO AIR BORN INTO HIS LANE OF TRAVEL. AS SOON AS UNIT 2 LANDED, UNIT 1 STRUCK UNIT 2. DRIVER OF UNIT 2 STATED HE THOUGHT HE HAD ENOUGH ROOM TO SWERVE FROM THE FREEWAY TO EXIT AND WAS LOOKING FOR ANY CARS.

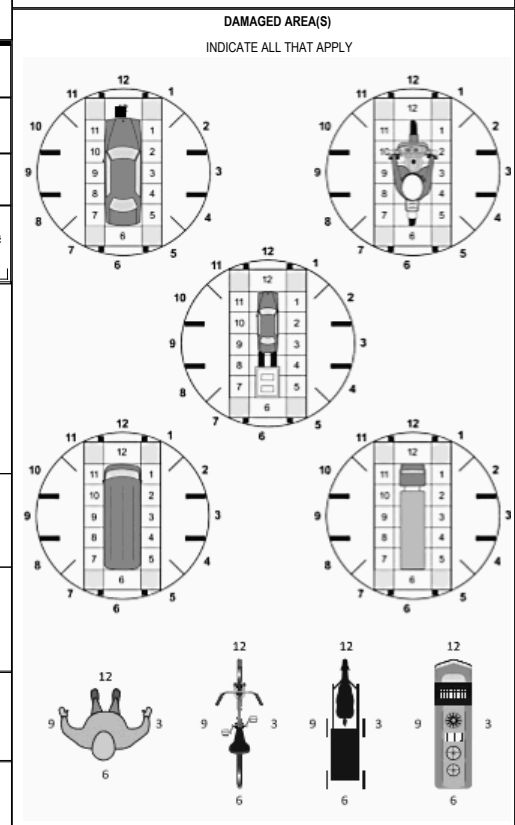
