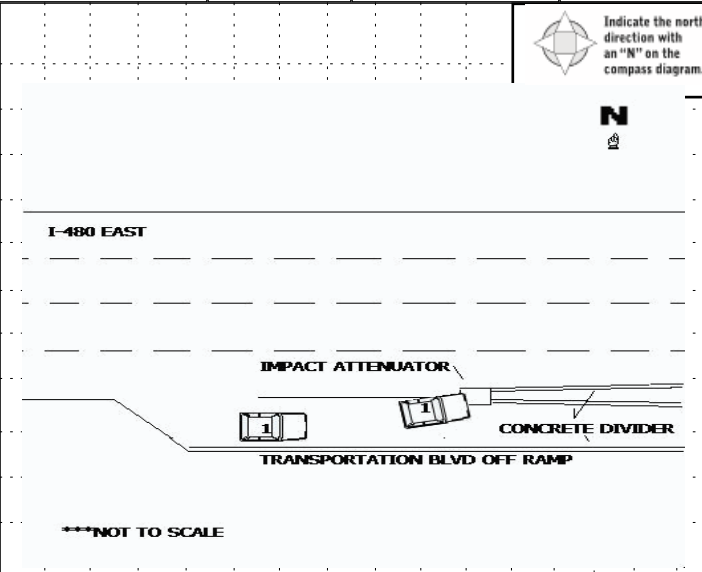

NARRATIVE
 UNIT 1 EXITED I-480 EAST AT THE TRANSPORTATION BLVD OFF RAMP. DRIVER OF UNIT 1 STATED HE FELT A PAIN IN HIS SIDE AND TOOK HIS EYES OFF THE ROAD FOR A MOMENT WHICH CAUSED UNIT 1 TO DRIVE LEFT OFF THE ROADWAY. UNIT 1 THEN STRUCK THE IMPACT ATTENUATOR AT THE BEGINNING OF THE CONCRETE BARRIER LOCATED ON THE LEFT SIDE OF THE OFF RAMP. UNIT 1 THEN SPUN COUNTER CLOCKWISE 180 DEGREES AND CAME TO REST IN ROADWAY. UNIT 1 SUFFERED HEAVY FRONT END DAMAGE AND WAS TOWED FROM SCENE.

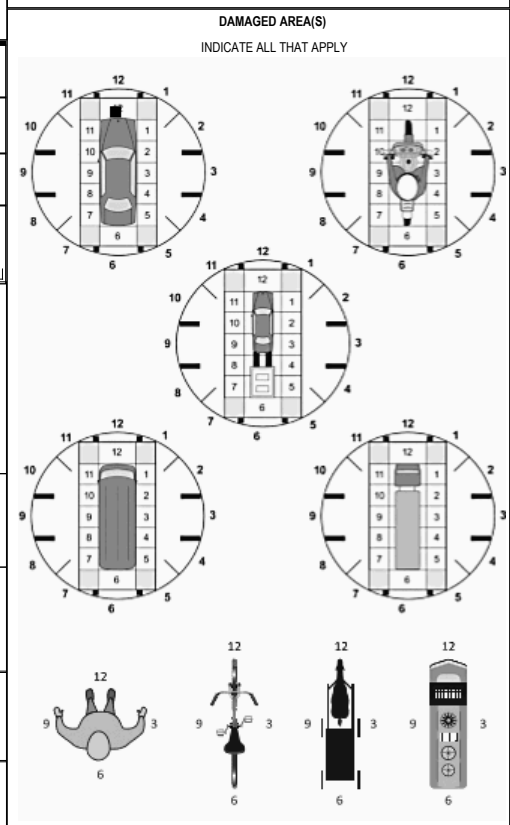
