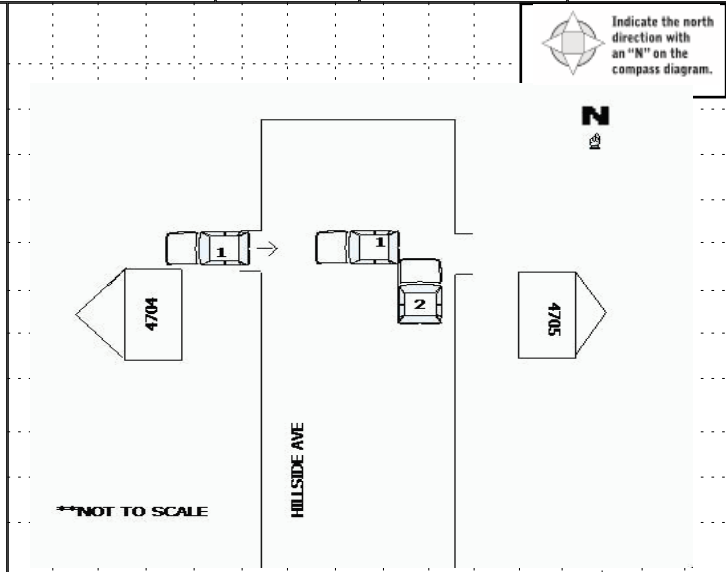

NARRATIVE

DRIVER OF UNIT 1 STATED THAT HE WAS BACKING OUT OF 4704 HILLSIDE AND DIDN'T SEE UNIT 2, WHICH WAS PARKED, PARTIALLY BLOCKING THE DRIVEWAY OF 4705. UNIT 1 BACKED INTO THE FRONT LEFT OF UNIT 2.

DRIVER OF UNIT 2 STATED THAT HE JUST BEGAN DRIVING FORWARD FROM BEING PARKED IN FRONT OF 4705 HILLSIDE, WHEN UNIT 1 BACKED OUT OF THE DRIVEWAY AND STRUCK THE FRONT LEFT OF UNIT 2. NO INJURIES REPORTED.

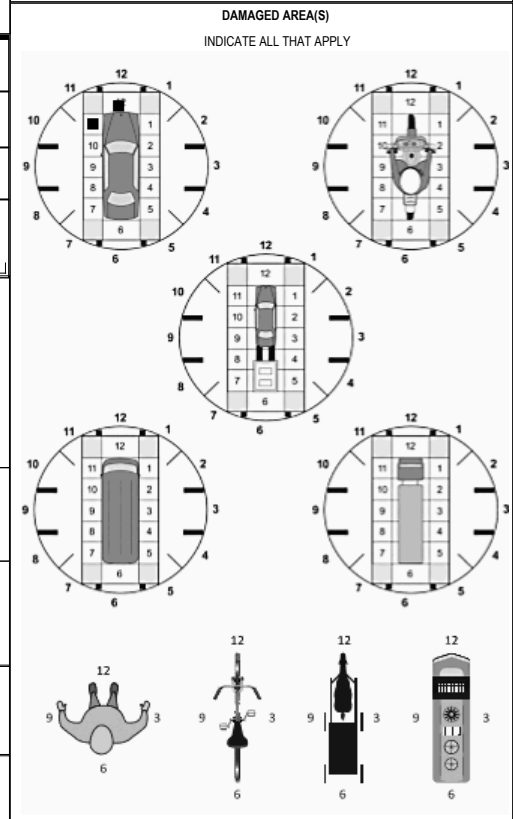
