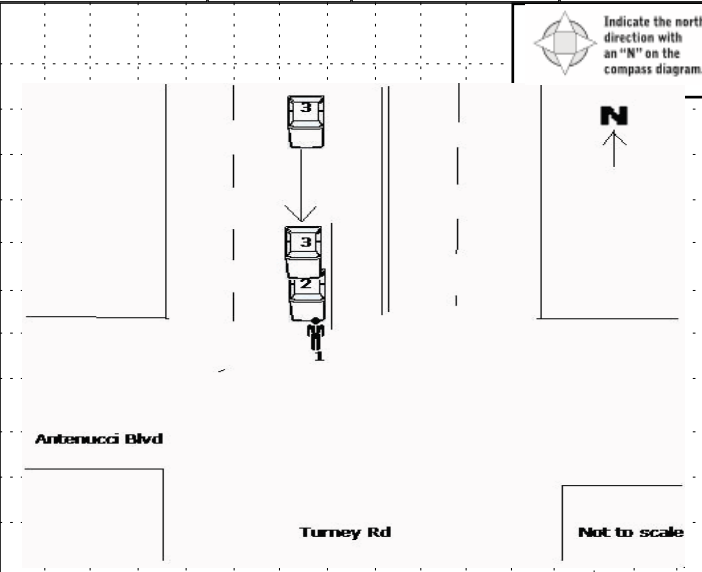

 UNIT ONE WAS DRIVING UNIT TWO SOUTH ON TURNEY RD IN THE CENTER LANE AND STRUCK A DEER. UNIT ONE STOPPED UNIT TWO THAT HE WAS DRIVING AND EXITED THE VEHICLE TO INSPECT THE DAMAGE. UNIT TWO WAS PARKED IN THE CENTER LANE ON TURNEY RD AT ANTENUCCI BLVD. UNIT THREE WAS TRAVELING BEHIND UNIT TWO AND FAILED TO MAINTAIN AN ASSURED CLEAR DISTANCE AND STRUCK UNIT TWO. UNIT TWO WAS THEN FORCED IN TO UNIT ONE WHO WAS IN FRONT OF HIS CAR LOOKING AT THE DAMAGE.

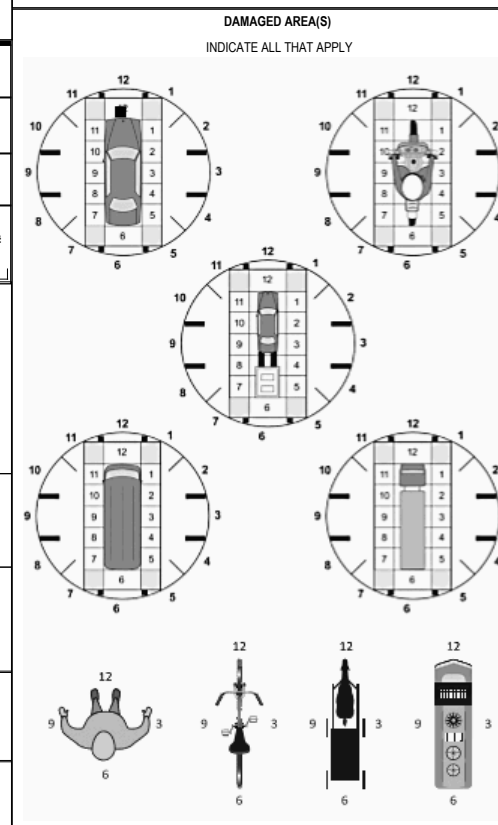
