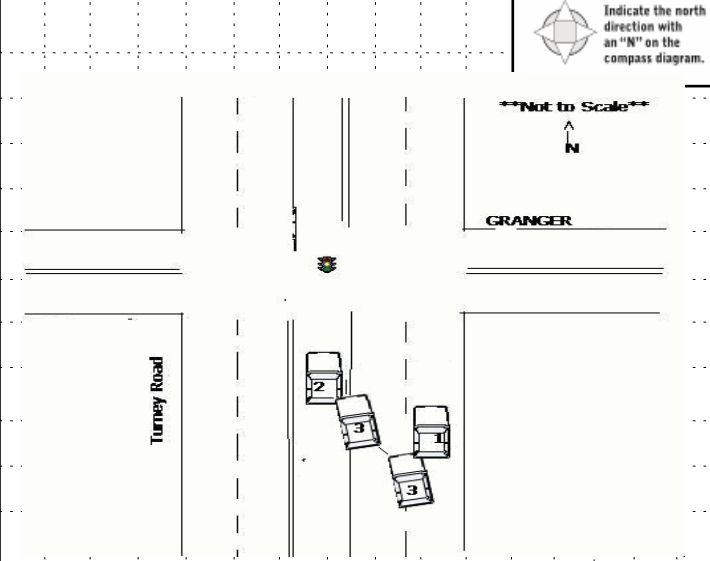

UNIT #3 STRUCK UNITS #1 AND #2. UNITS #1 WAS IN THE CURB LANE. UNIT #2 WAS IN THE TURNING LANE. PTL. FOXX TESTED THE BRAKES OF UNIT #3 AND STATED THEY WERE SOFT BUT OPERABLE.

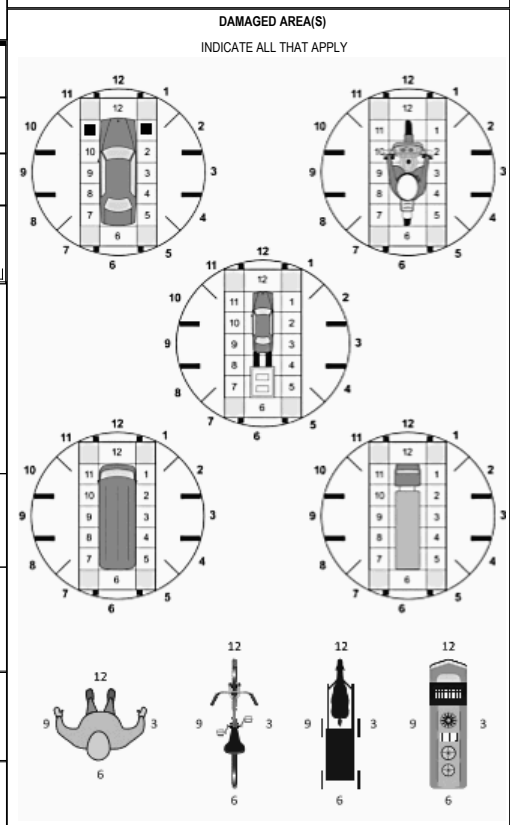

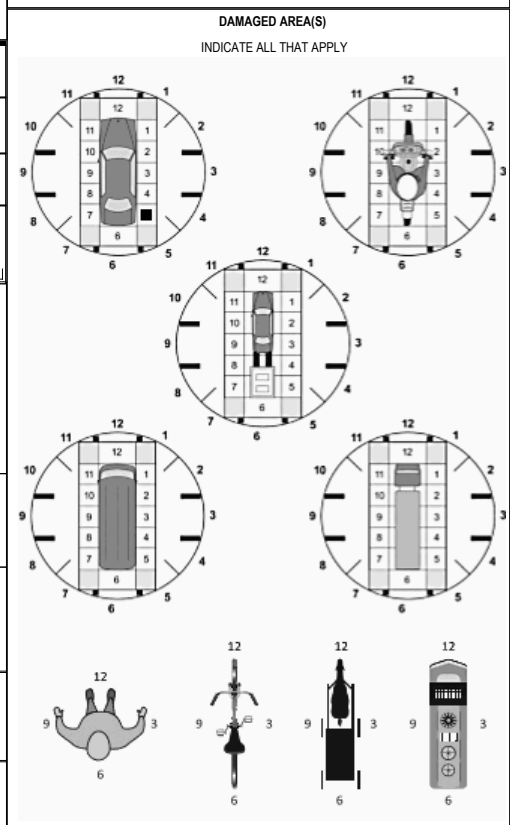

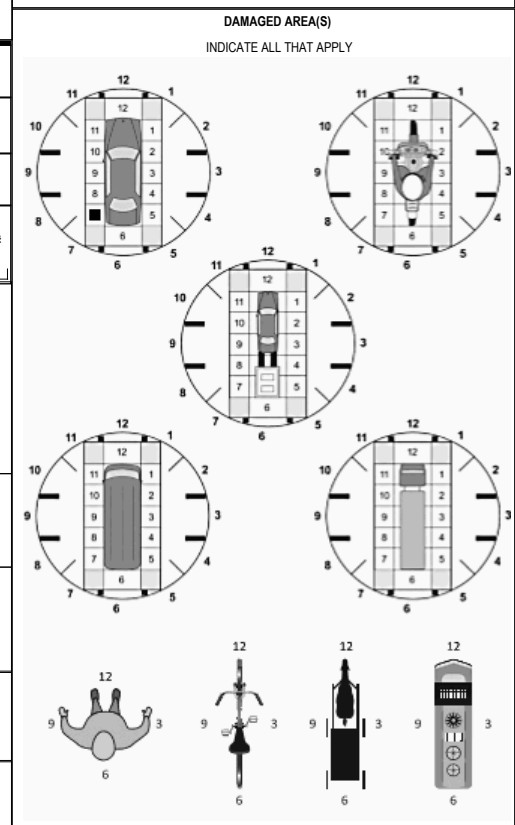
