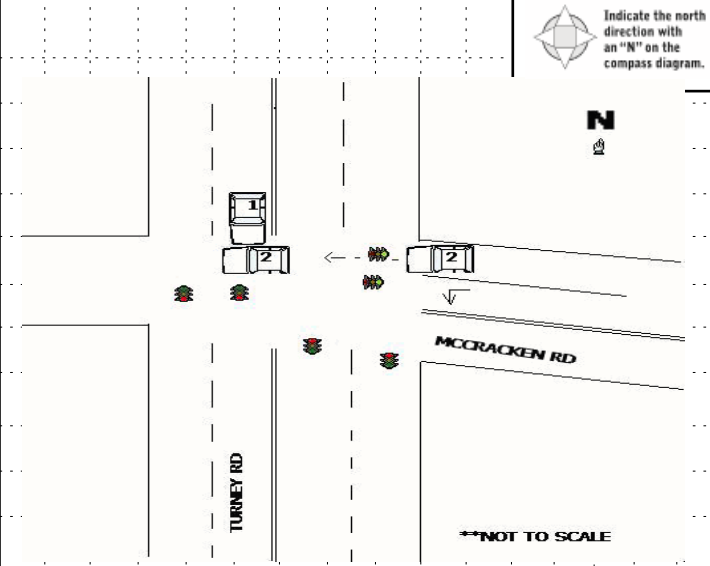

UNIT 2 WAS TRAVELING W/B ON MCCRACKEN RD. THE TRAFFIC SIGNAL TURNED GREEN AT TURNEY RD AND UNIT 2 BEGAN TO TRAVEL THROUGH THE INTERSECTION, WHEN IT WAS STRUCK ON THE RIGHT FRONT BY UNIT 1, WHICH DROVE THROUGH THE RED LIGHT S/B ON TURNEY RD. THIS OFFICER WATCHED THE CITY'S VIDEO SURVEILLANCE AND OBSERVED UNIT 1 TRAVEL THROUGH THE RED LIGHT APPROXIMATELY 5 SECONDS AFTER IT TURNED RED. UNIT 2 WAS ABLE TO BE MOVED OFF THE ROADWAY AFTER POLICE ARRIVAL. NO INJURIES REPORTED.

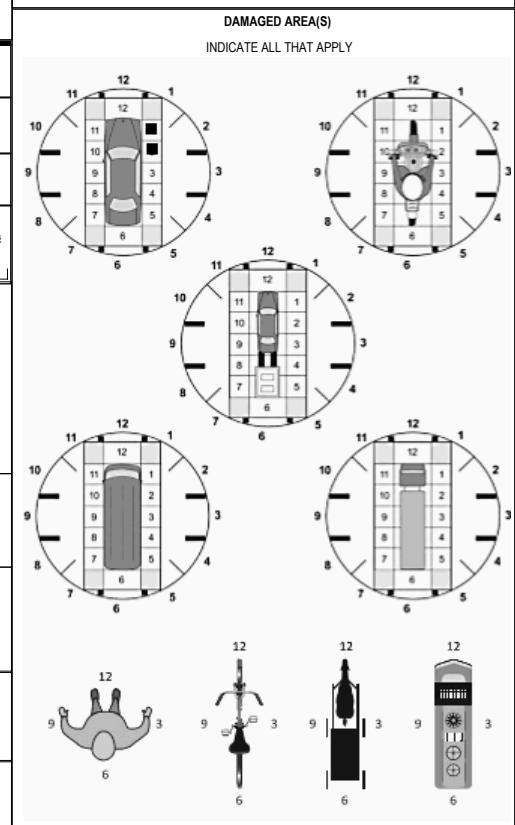
