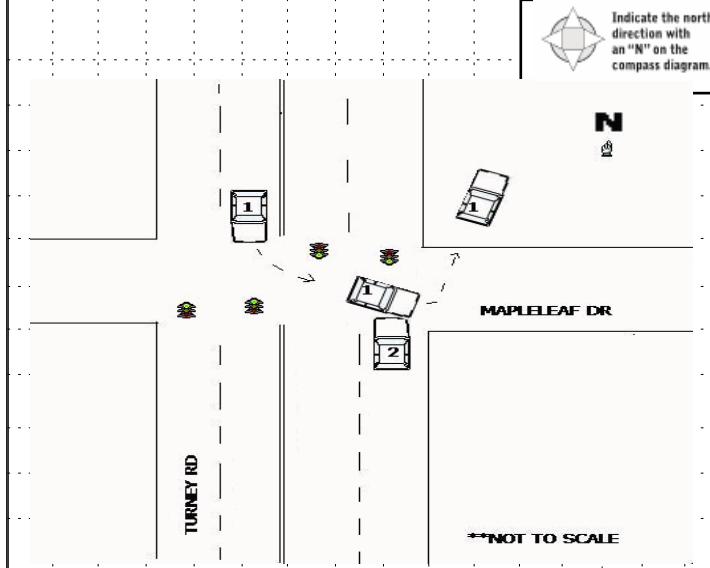

UNIT 2 WAS TRAVELING N/B ON TURNEY RD IN THE CURB LANE. UNIT 1 WAS TRAVELING S/B ON TURNEY RD IN THE LEFT LANE AND BEGAN TO MAKE A LEFT TURN ONTO MAPLELEAF DR. UNIT 1 FAILED TO YIELD TO UNIT 2 AND UNIT 2 STRUCK THE RIGHT SIDE OF UNIT 1. THE FORCE OF THE CRASH SPUN UNIT 1 90 DEGREES COUNTER CLOCKWISE AND IT THEN DROVE OFF THE ROADWAY AND CAME TO REST IN FRONT OF 5753 TURNEY RD. BOTH DRIVERS COMPLAINED OF MINOR INJURIES AND WERE TREATED AND RELEASED ON SCENE BY EMS.

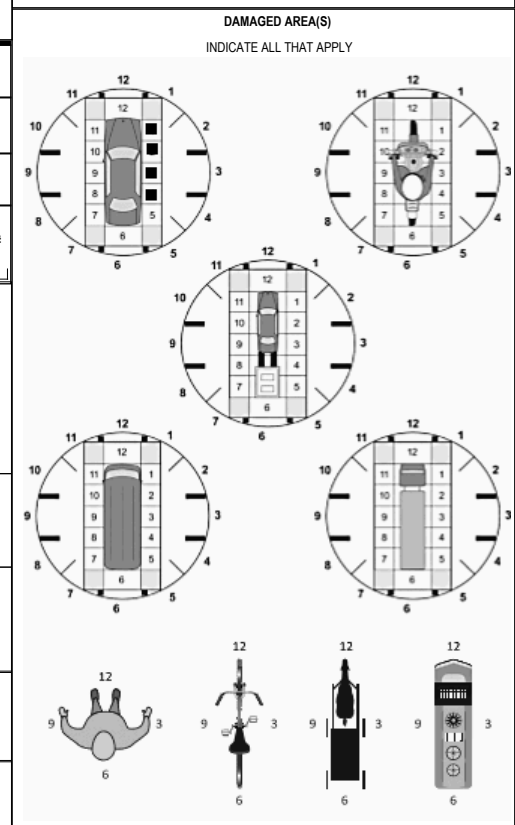
