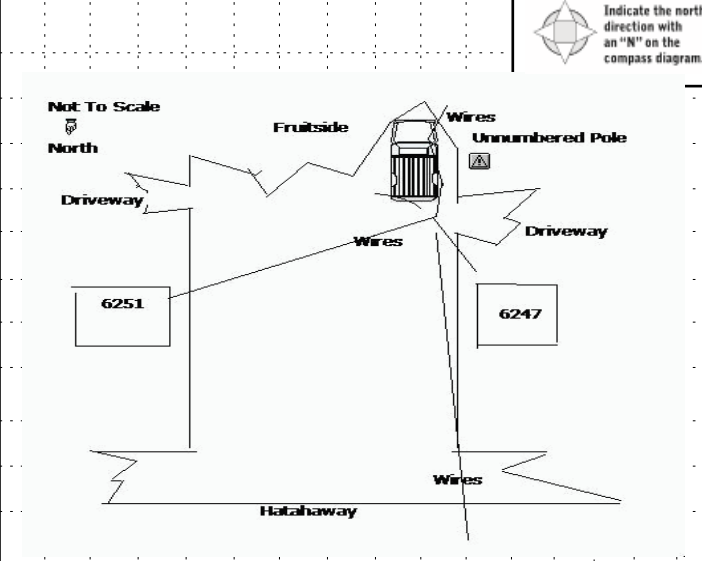

 UNIT # 1 WAS TRAVELING SOUTH ON FRUITSIDE APPROXIMATELY 100' SOUTH OF HATHAWAY ON THE RIGHT SIDE OF THE ROADWAY. AS A RESULT AND FOR UNKNOWN REASONS, THE TOP OF UNIT # 1 COLLIDED WITH WIRES. UNIT # 1 CONTINUED TO TRAVEL SOUTH WHILE IN CONTACT WITH THE WIRES. THE WIRES PULLED WERE CONNECTED TO 6251 AND 6247 HATHAWAY. UNIT # 1 WAS AT FINAL REST UPON ARRIVAL.
