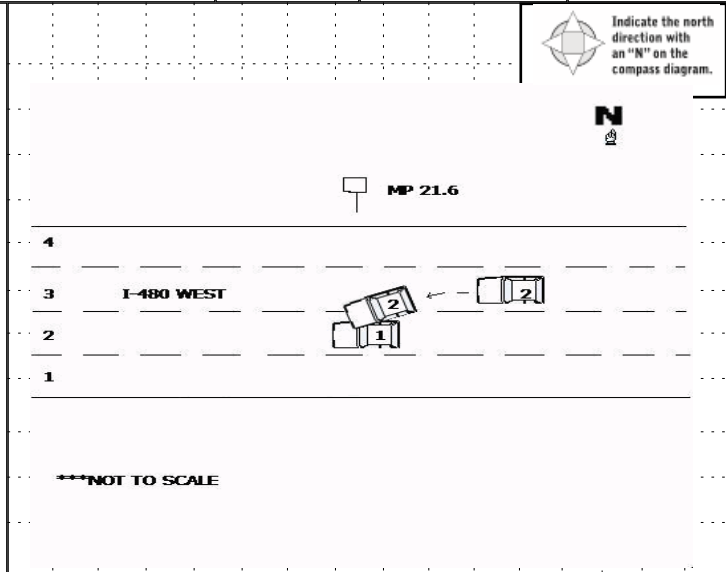

THIS OFFICER MET DRIVER OF UNIT 1 IN PARKING LOT OF 9791 VISTA WAY. HE STATED THAT UNIT 1 WAS TRAVELING ON I-480 WEST IN LANE 2. WHILE NEAR MILE MARKER 21.6, UNIT 2 WAS TRAVELING IN LANE 3 AND SWERVED INTO LANE 2 TO AVOID A CRASH. UPON DOING SO, UNIT 2 FAILED TO YIELD TO UNIT 1 AND STRUCK THE RIGHT SIDE OF UNIT 1. UNIT 2 FLED THE AREA AFTER THE CRASH. ONLY DESCRIPTION PROVIDED FOR UNIT 2 WAS A RED PICK UP TRUCK.

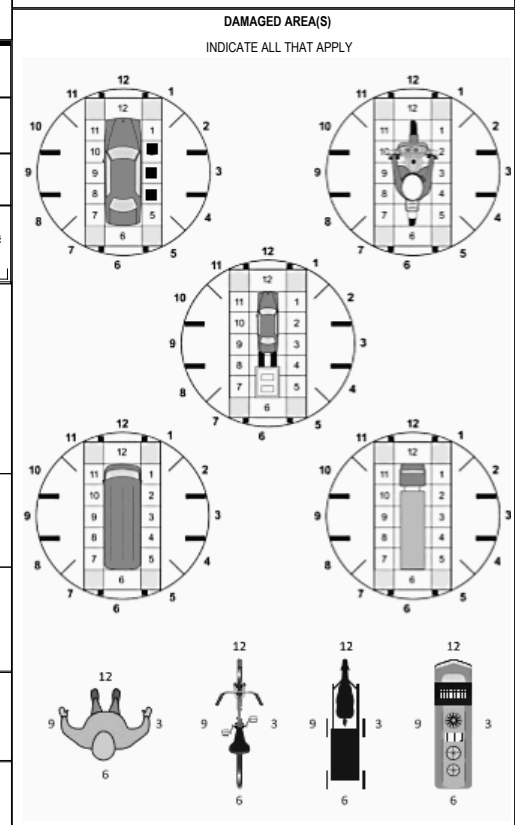
