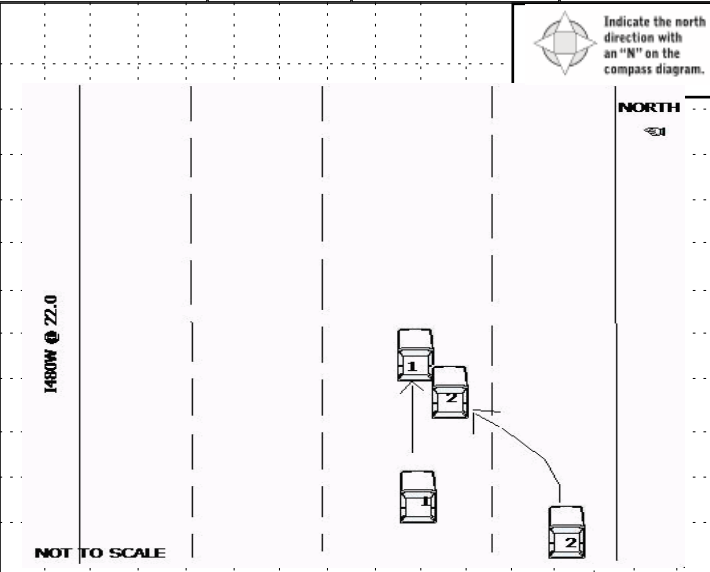

 UNIT 1 WAS TRAVELING 480 W NEAR 22.0. UNIT 2 WAS TRAVELING NEXT TO UNIT 1 ON 480 W. UNIT 2 CAME INTO UNIT 1'S LANE CAUSING SAME DIRECTION SIDE SWIPE DAMAGE ALONG THE ENTIRE RIGHT SIDE OF UNIT 1 AND DAMAGE ON THE LEFT SIDE OF UNIT 2. BOTH UNITS EXITED AT TRANSPORTATION BUT UNIT 2 CONTINUED TOWARD GRANGER AND FAILED TO STOP FOR THE ACCIDENT.  
 UNIT 2 IS DESCRIBED AS A GRAY CAR WITH POSSIBLE/PARTIAL PLATE HT9561 OPERATED BY A YOUNG BLACK MALE.

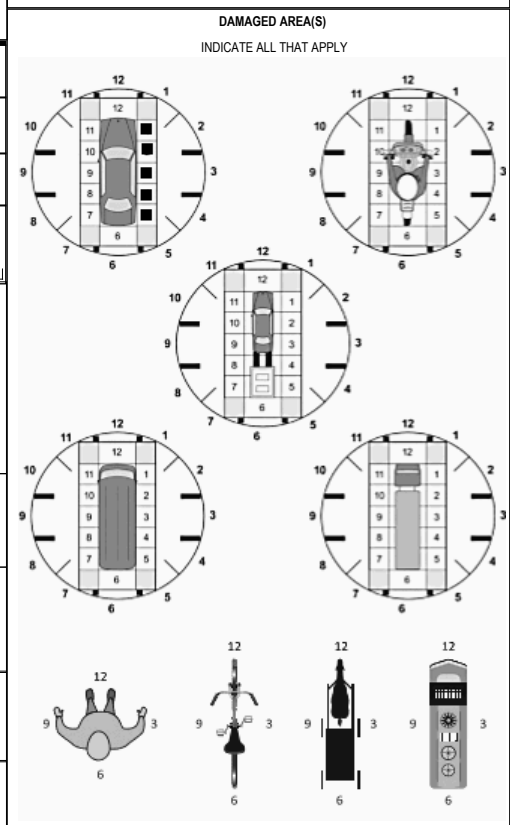
