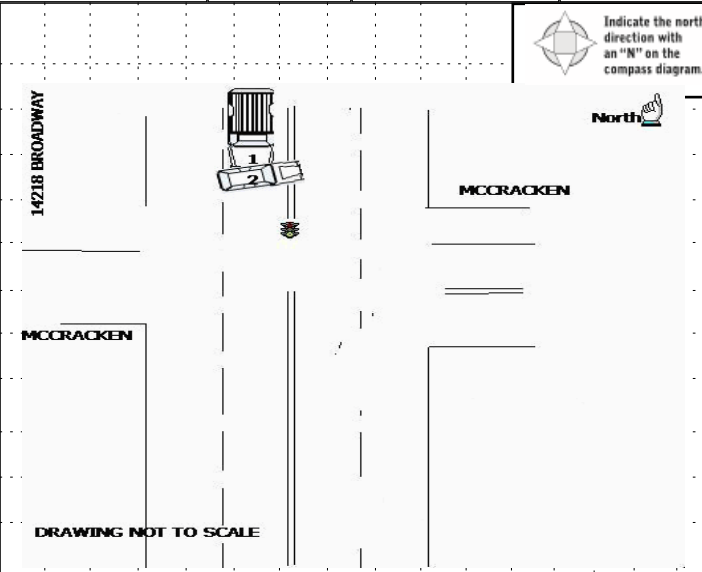

THE LIGHT TURNED GREEN AND UNIT 1 STARTED TO GO WHEN UNIT 2 PULLED OUT OF THE GAS STATION AT 14218 BROADWAY IN FRONT OF UNIT 1. UNIT 2 STATES SHE WAS PULLING OUT OF THE GAS STATION AND A DRIVER OF A VEHICLE IN THE CURB LANE WAVED HER ON AT WHICH TIME SHE PULLED OUT IN FRONT OF UNIT 1 CAUSING UNIT 1 TO STRIKE UNIT 2.

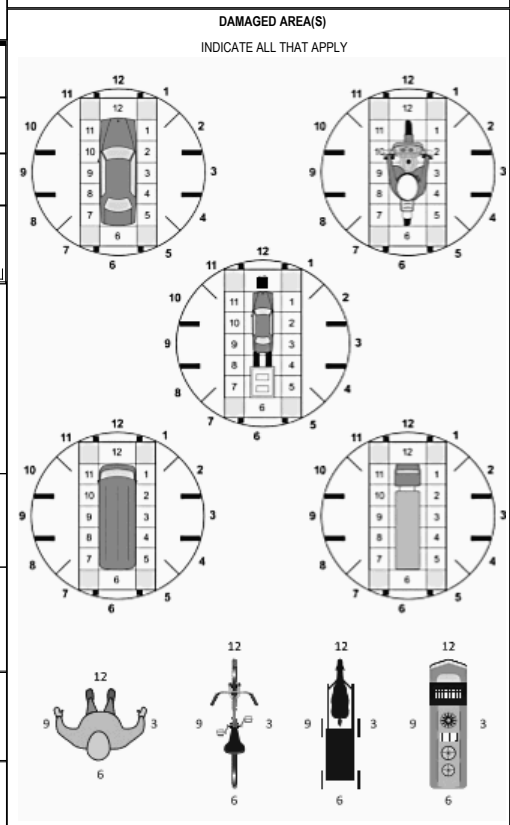

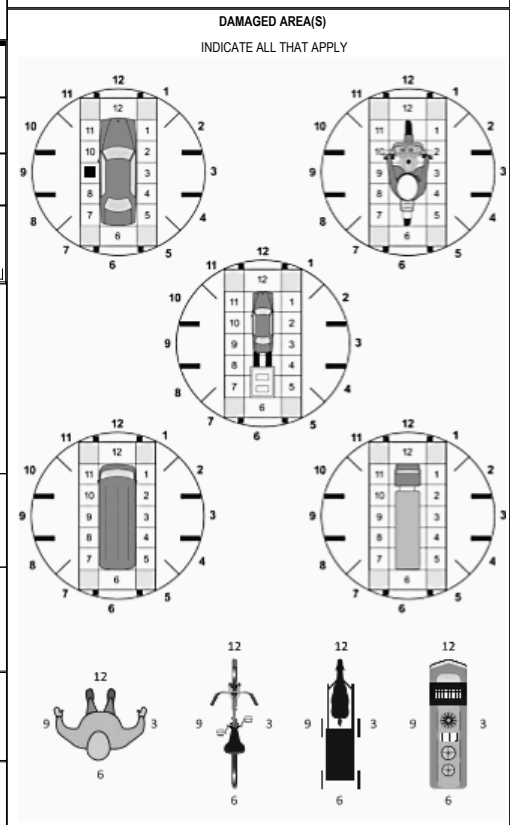
