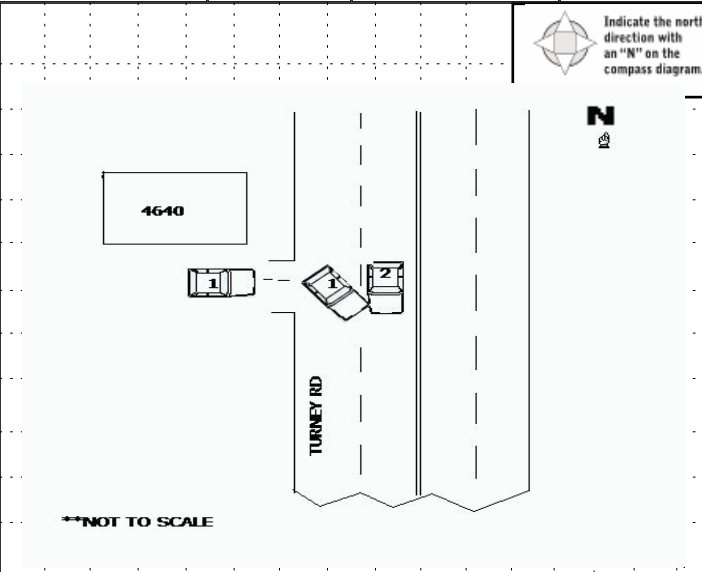

UNIT 1 WAS EXITING THE PARKING LOT AT 4640 TURNEY RD AND ATTEMPTING TO TURN RIGHT ONTO TURNEY. UNIT 1 FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING S/B ON TURNEY RD IN THE LEFT LANE. UNIT 1 STRUCK UNIT 2 ON THE RIGHT FRONT AREA AND THEN FLED THE AREA AFTER THE CRASH. UNIT 1 WAS LOCATED A SHORT TIME LATER. IT WAS PARKED UNOCCUPIED A COUPLE STREETS AWAY ON THE CORNER OF DOROTHY AND EAST 94TH.

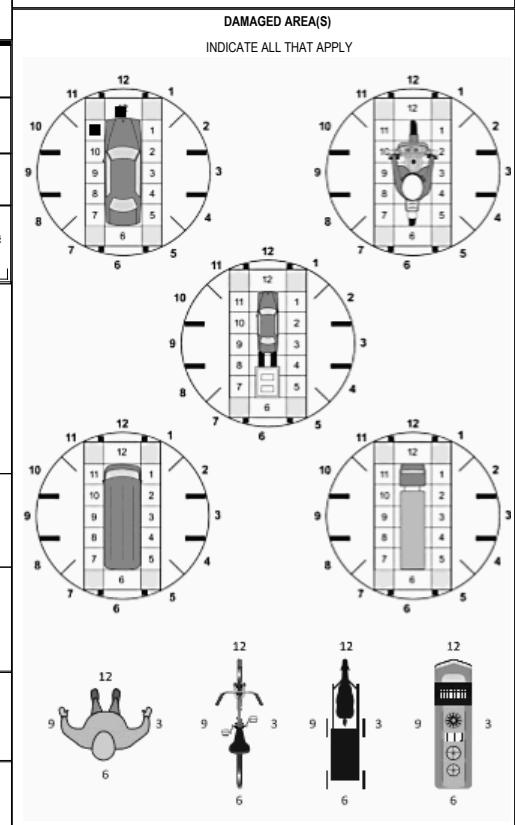
