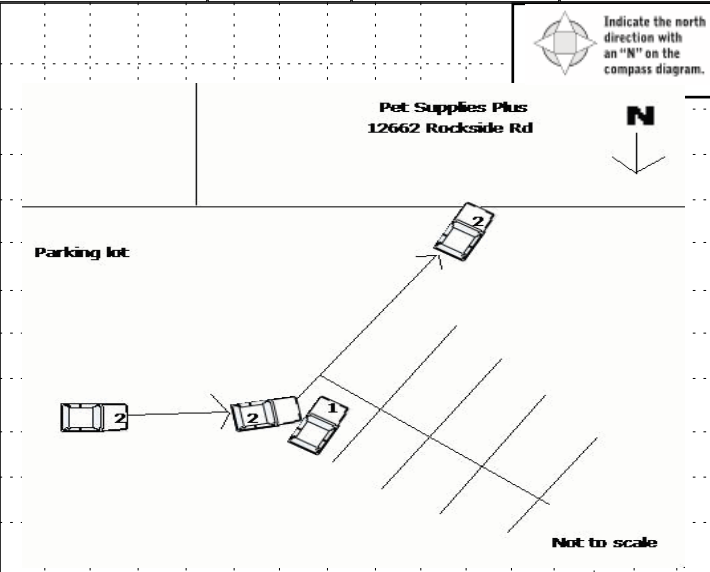

UNIT ONE WAS PARKED UNATTENDED IN THE LOT OF PET SUPPLIES PLUS (12662 ROCKSIDE RD) UNIT TWO WAS TRAVELING WEST THROUGH THE LOT AND RACING ANOTHER VEHICLE. UNIT TWO LOST CONTROL OF HER VEHICLE AND CRASHED INTO UNIT ONE. UNIT TWO THEN CRASHED IN TO THE FRONT OF PET SUPPLIES PLUS. UNIT TWO WAS BEING DRIVEN BY A FEMALE WHO HAD NO DRIVERS LICENSE. THE OWNER OF UNIT TWO ALLOWED HIS BROTHER TO USE THE VEHICLE. HIS BROTHER THEN ALLOWED THE UNLICENSED DRIVER TO DRIVE THE VEHICLE AND THEN CRASHED.

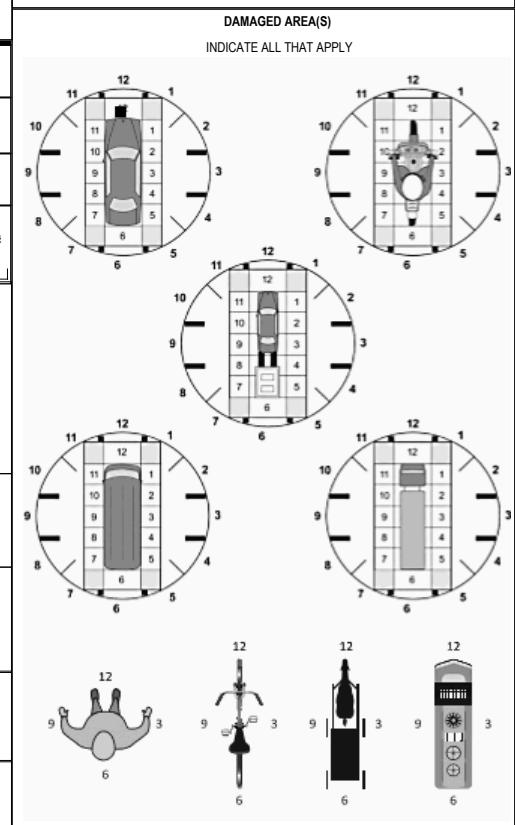

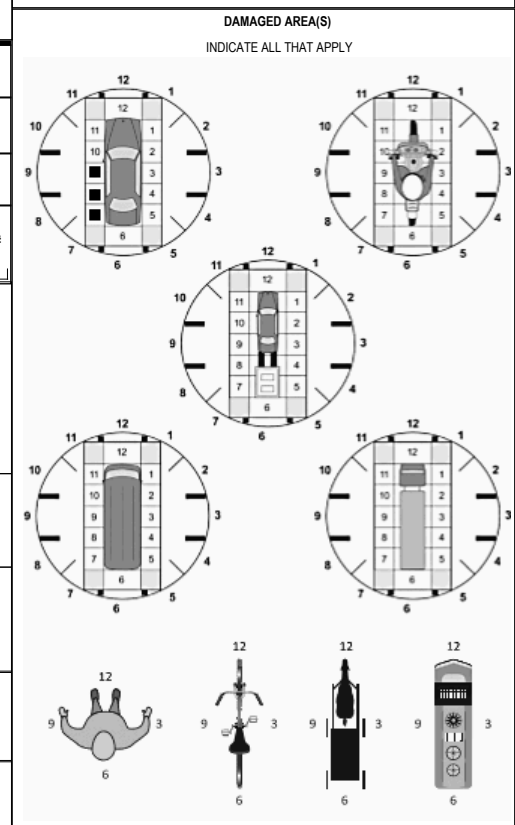
