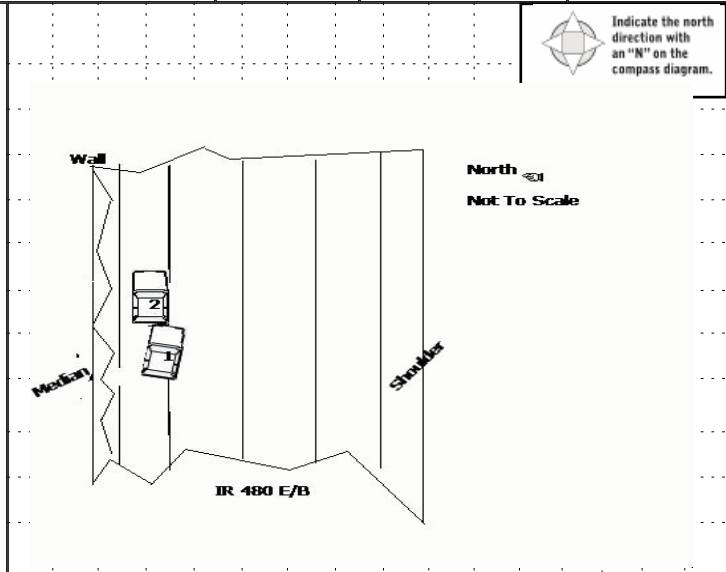

UNIT # 1 WAS TRAVELING EAST ON IR 480 NEAR MILE MARKER 21.6 IN THE INSIDE LANE DIRECTLY BEHIND UNIT # 2. UNIT # 2 SLOWED FOR TRAFFIC. UNIT # 1 ATTEMPTED TO TAKE EVASIVE ACTION TO THE RIGHT. AS A RESULT, THE LEFT FRONT OF UNIT # 1 COLLIDED WITH THE RIGHT REAR OF UNIT # 2. BOTH UNITS WERE MOVED FROM FINAL REST AND WERE PARKED ON THE SOUTH SHOULDER OF IR 480 FACING EAST.

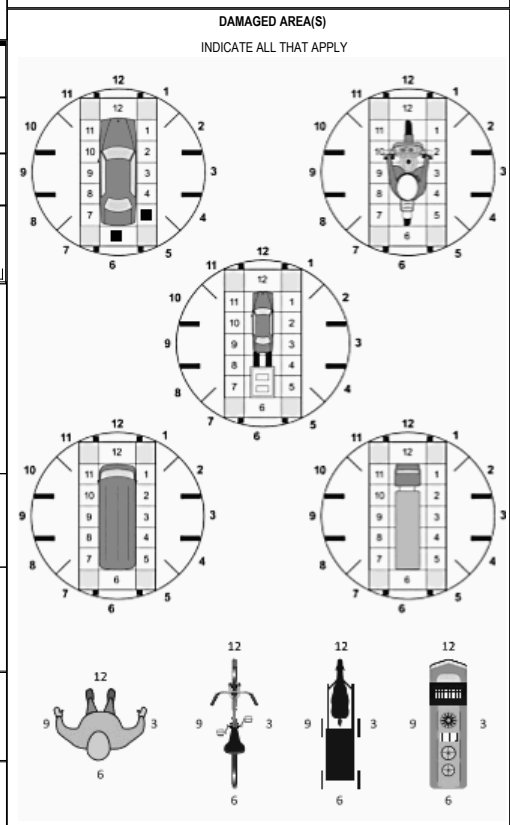

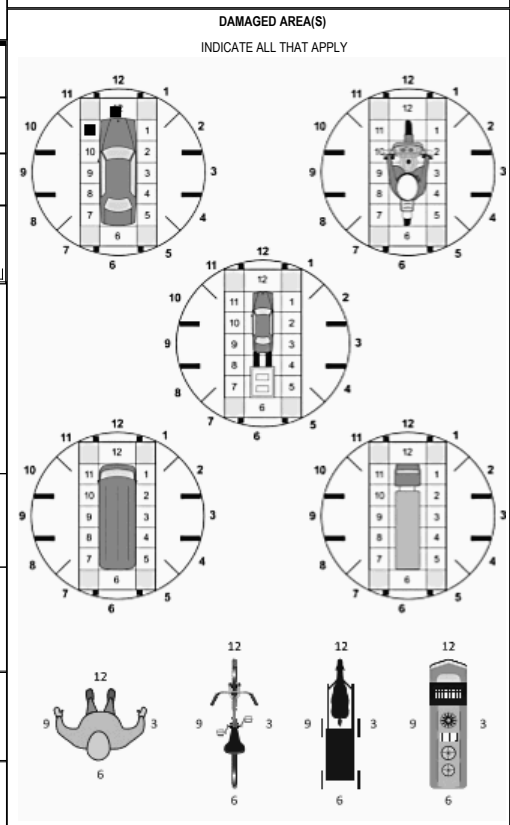
