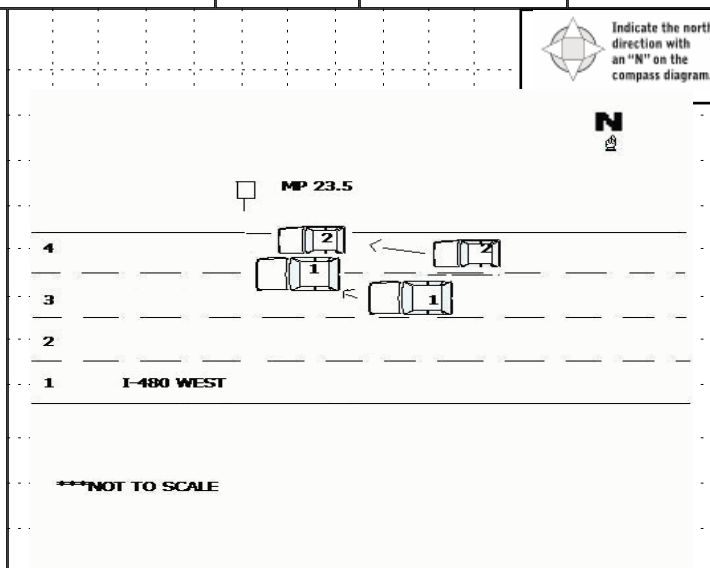

 WHILE TRAVELING NEAR MILE POST 23.5, UNIT 1  
 BEGAN TO CHANGE LANES INTO LANE 4 AND FAILED  
 TO OBSERVE UNIT 2, WHICH WAS NEXT TO UNIT 1.  
 UNIT 2 OBSERVED UNIT 1 START TO DRIVE INTO  
 LANE 4 AND WAS FORCED ONTO THE RIGHT  
 SHOULDER. UNIT 2 COULDN'T AVOID THE CRASH  
 AND UNIT 1 STRUCK THE LEFT SIDE OF UNIT 2. BOTH  
 VEHICLES PULLED OVER AFTER CRASH. UNIT 2 HAD  
 DASH CAM VIDEO OF INCIDENT THAT WAS VIEWED  
 BY THIS OFFICER. NO INJURIES REPORTED.

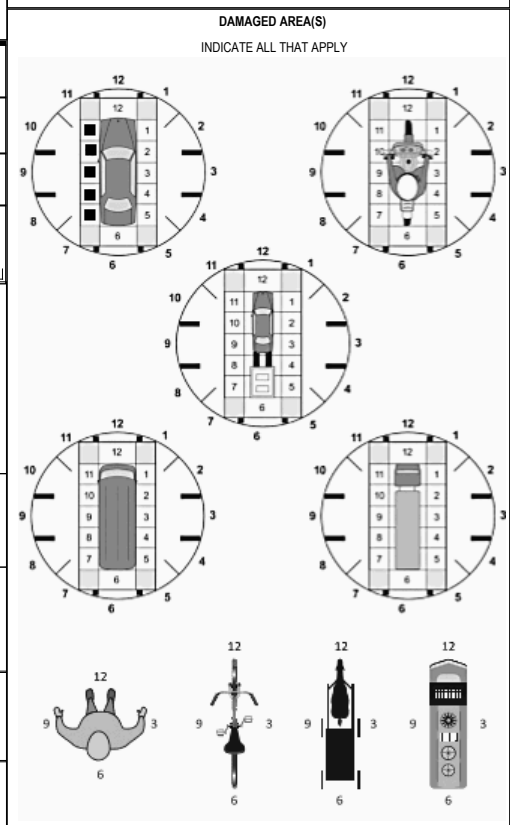

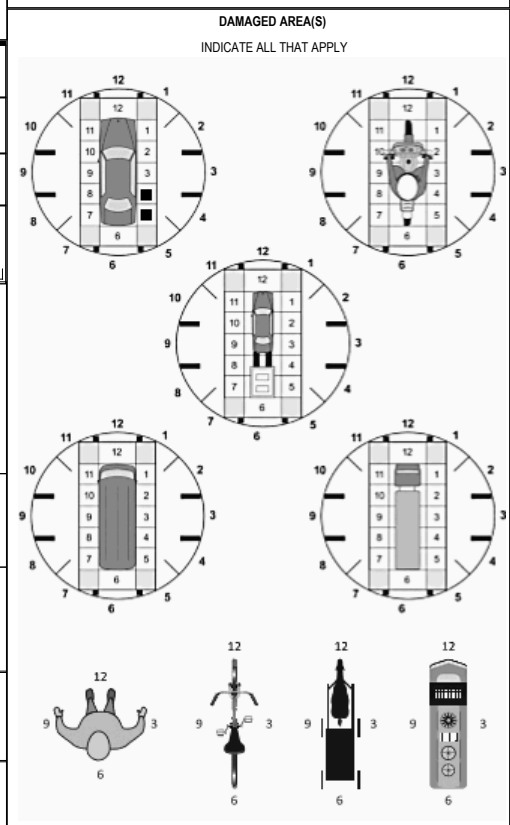
