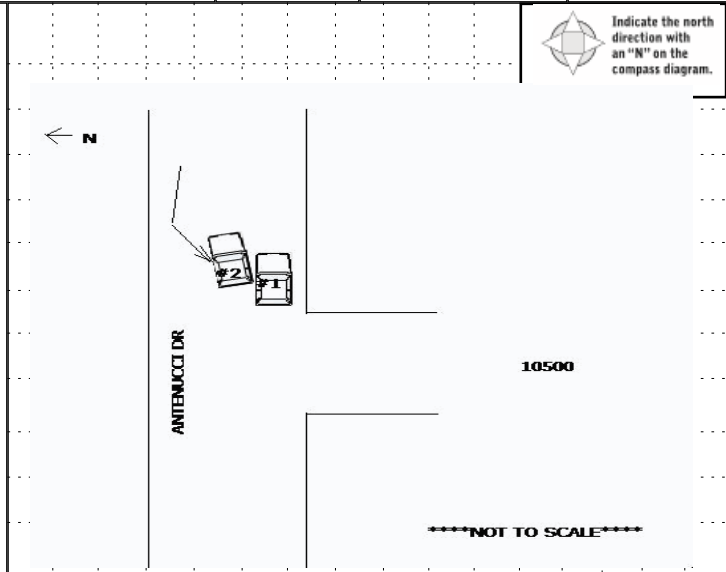

UNIT #1 WAS E/B ON ANTENUCCI DR. UNIT #2 (HIT-S KIP VEHICLE) WAS W/B ON ANTENUCCI DR. AND APPLIED BRAKES SUDDENLY IN ORDER TO AVOID REAR ENDING A VEHICLE THAT WAS STOPPED TO TURN LEFT INTO 10500 ANTENUCCI DR., FISHTAILED, SLID SIDWAYS (180 DEGREES), AND STRUCK THE DRIVERS SIDE OF UNIT #1. UNIT #2 THEN FLED THE SCENE E/B ON ANTENUCCI DR. THE WITNESS DESCRIBED UNIT #2 AS A MAROON CHEVY ENVOY.

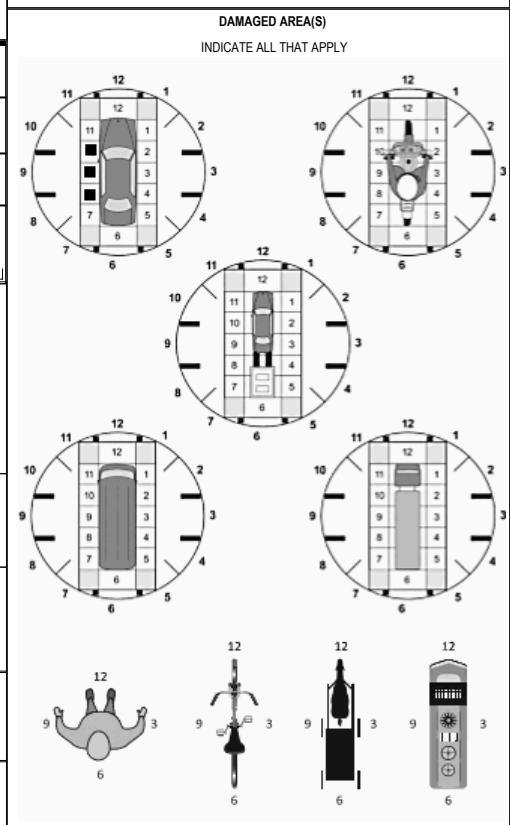
