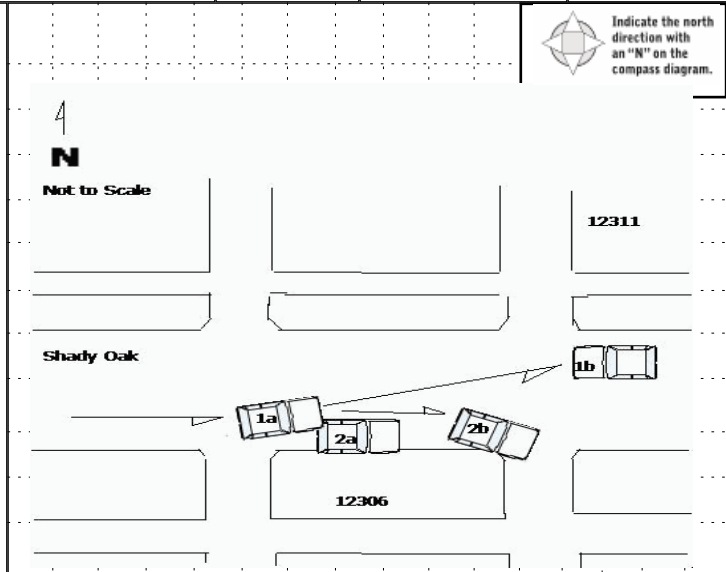

UNIT 2 WAS PARKED UNOCCUPIED ON SHADY OAK IN FRONT OF 12306. UNIT 1 WAS TRAVELING E/B AND STRUCK UNIT 2 AT THE REAR. UNIT 1 LOST CONTROL AND ROLLED OVER COMING TO REST FACING W/B IN FRONT OF 12311. WITNESSES STATED THEY ASSISTED THE DRIVER OUT OF UNIT 1. THE DRIVER RETURNED TO THE VEHICLE WHERE HE RETRIEVED A HANDGUN AND SEVERAL BLACK "B AGGIES" BEFORE FLEEING SOUTH FROM THE AREA THROUGH THE YARD OF 12324. UNIT 1 WAS RENTED FROM HERTZ RENTAL. SEVERAL ATTEMPT WERE MADE TO CONTACT WITH NEGATIVE RESULTS.

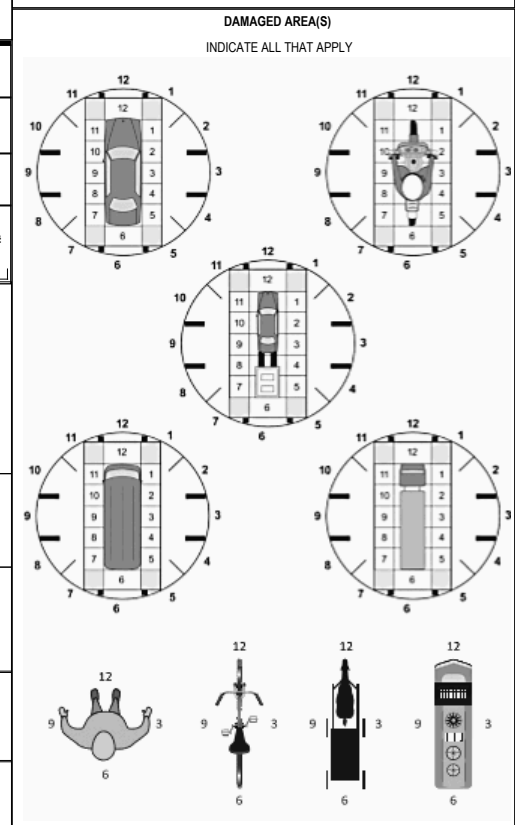

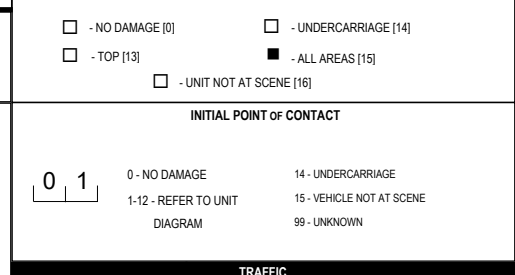

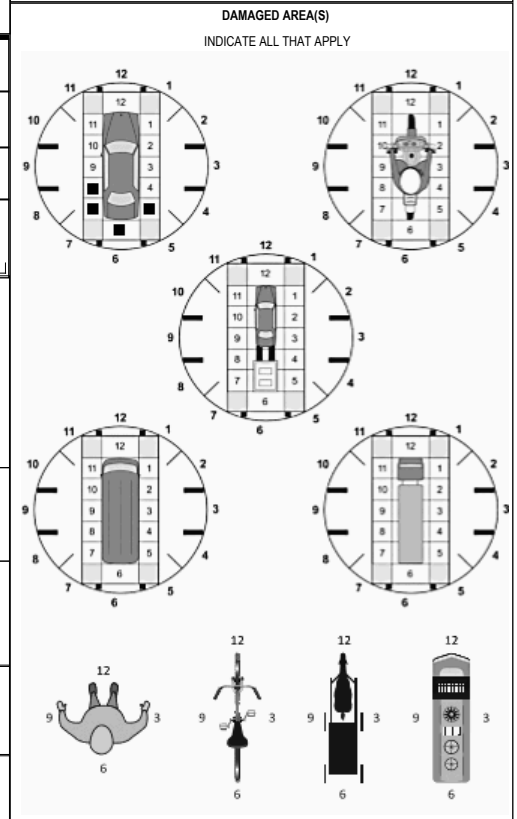
