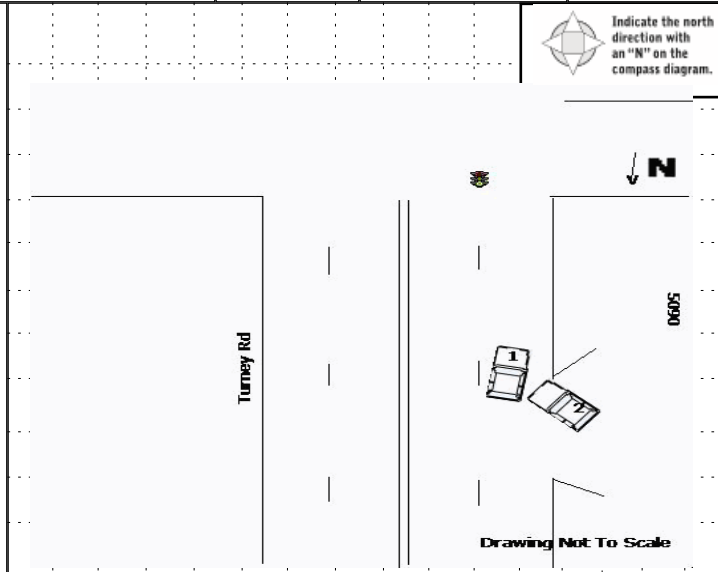

AS THE TRUCK AND TRAILER BEGAN MOVING FOR A GREEN LIGHT, UNIT 1 STARTED TO MOVE. UNIT 2 WAS IN THE LOT OF 5090 TURNEY BEHIND THE TRAILER. UNIT 2 CONTINUED TO FOLLOW THE TRAILER EXITING THE LOT CAUSING UNIT 1 TO VEER OUT OF THE WAY FROM GETTING STRUCK. UNIT 2 STRUCK THE RIGHT REAR OF UNIT 1.

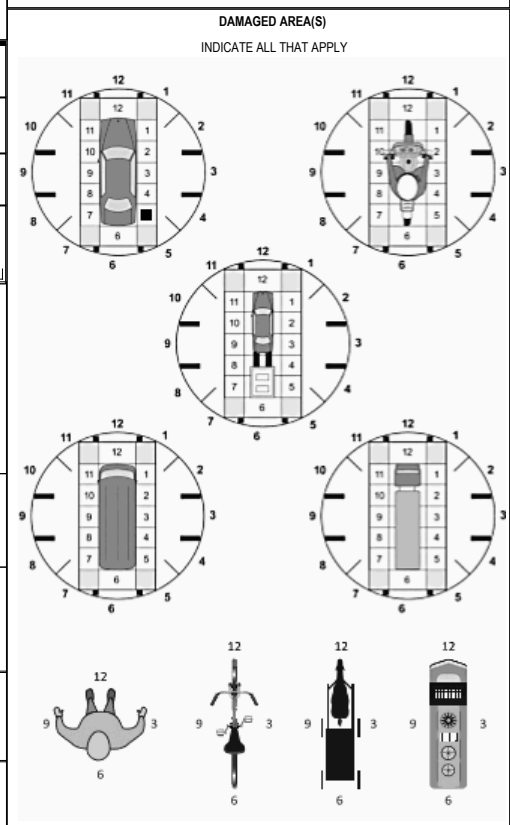

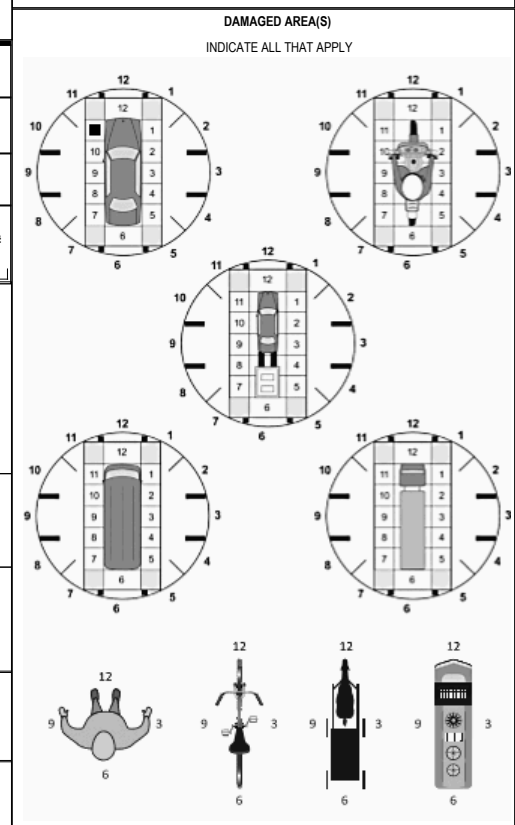
