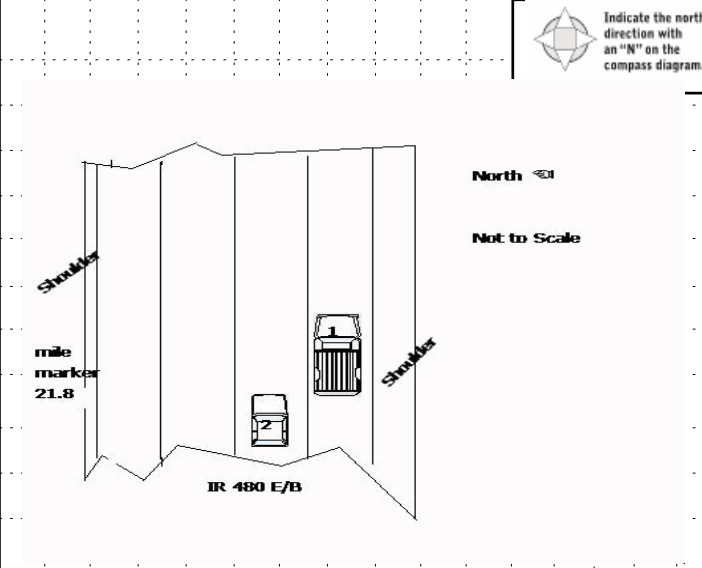

AS A RESULT, AN UNKNOWN OBJECT CAME FROM THE LEFT REAR WHEEL WELL OF UNIT #1 AND COLLIDED WITH THE RIGHT SIDE OF UNIT # 2. BOTH UNITS WERE PARKED ON IR 480 E/B SOUTH SHOULDER UPON ARRIVAL.
 NOTE: DRIVER OF UNIT # 2 STATED, THE UNKNOWN OBJECT FELL FROM BETWEEN THE TIRE AND BODY OF THE TRUCK.

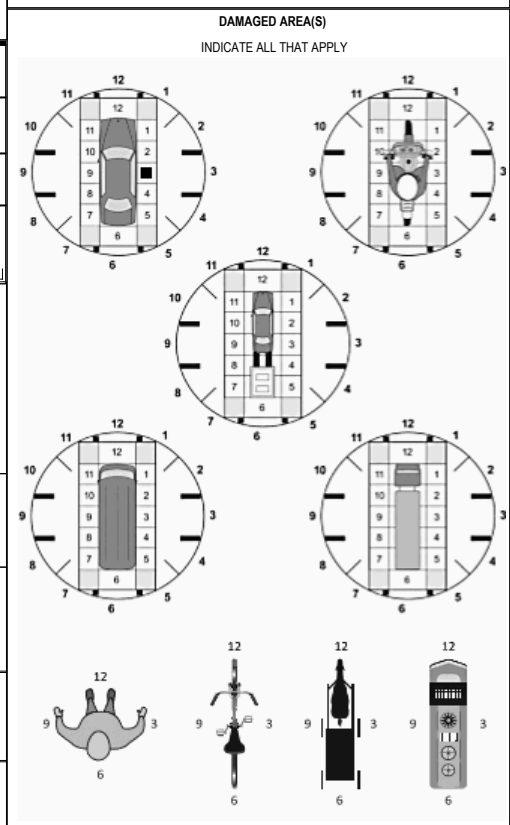
