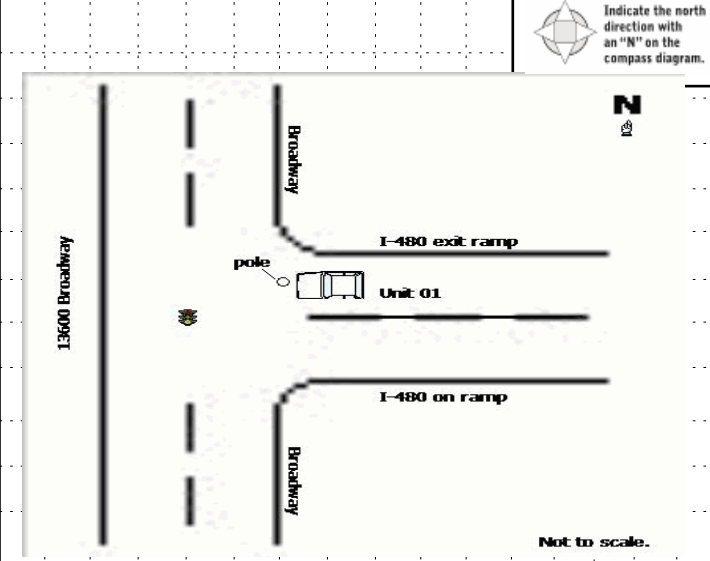

UNIT 01 DROVE OVER A CURB, THEN STRUCK A CROSS WALK SIGNAL POLE WITH THE FRONT CENTER OF UNIT 01, CONTINUED ACROSS BROADWAY OVER ANOTHER CURB, AND THEN CAME TO A STOP IN THE LOT OF 13600 BROADWAY.

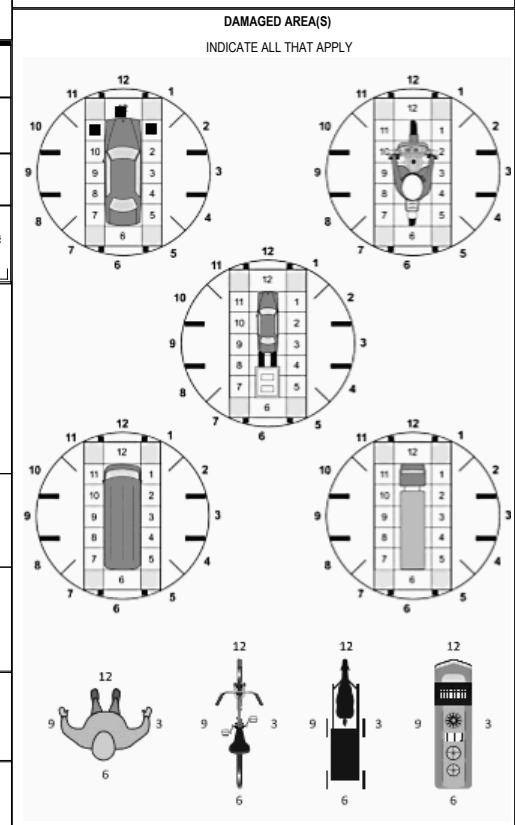
