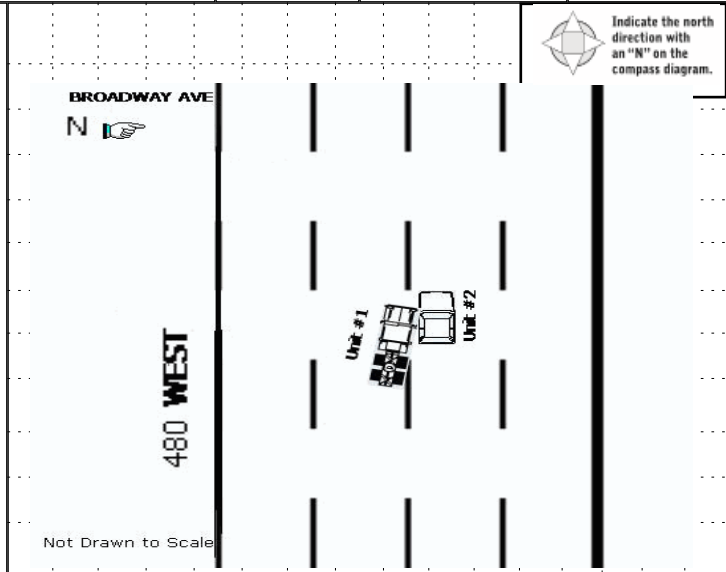

UNIT #2 WAS IN THE SAME LOCATION AND TRAVELING THE SAME DIRECTION IN LANE 2 WHEN UNIT #1 & #2 STRUCK ONE ANOTHER AFTER UNIT #2 TRAVELED AROUND UNIT #1 USING LANE 3.

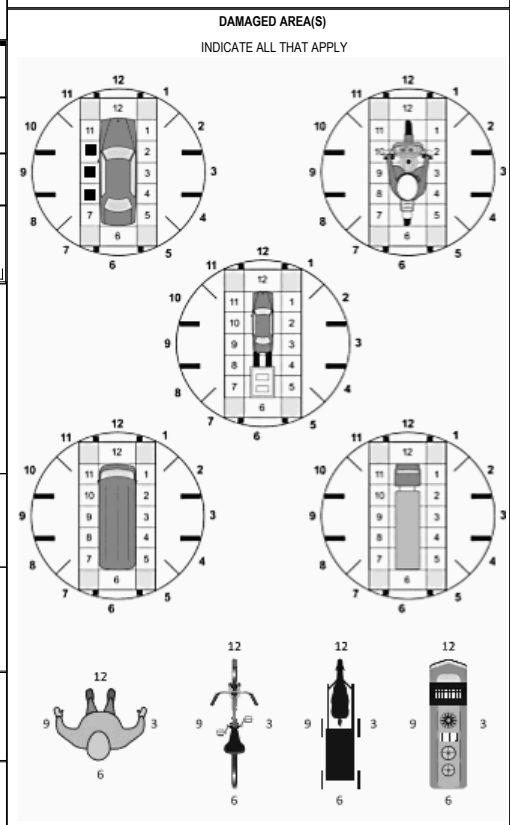
