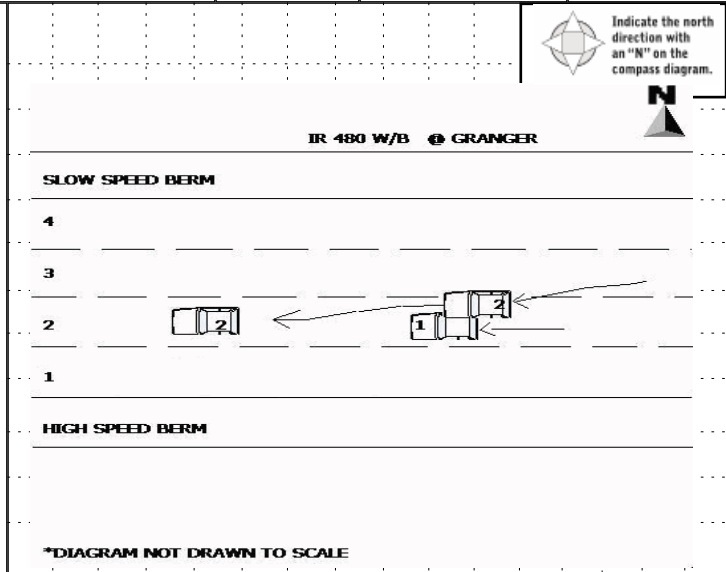

 UNIT 1 (MOTORCYCLE) WAS TRAVELING WEST ON I480 NEAR GRANGER RD IN LANE 2. UNIT 2 WAS TRAVELING I480W IN LANE 3 DIRECTLY NEXT TO UNIT 1. UNIT 2 MADE AN IMPROPER LANE CHANGE AND MADE CONTACT WITH THE RIGHT SIDE OF UNIT 1 WITH THE LEFT SIDE OF UNIT 2. UNIT 2 THEN BEGAN TO PULL OVER INTO THE SLOW SPEED BERM BUT THEN CONTINUED TO DRIVE WEST ON 480 AND FAILED TO STOP AFTER THE ACCIDENT. UNIT 1 STATED THAT HE BELIEVES UNIT 1 HAD A DEALER PLATE OF 6059077 ON IT AND WAS A BLACK CHRYSLER 200.

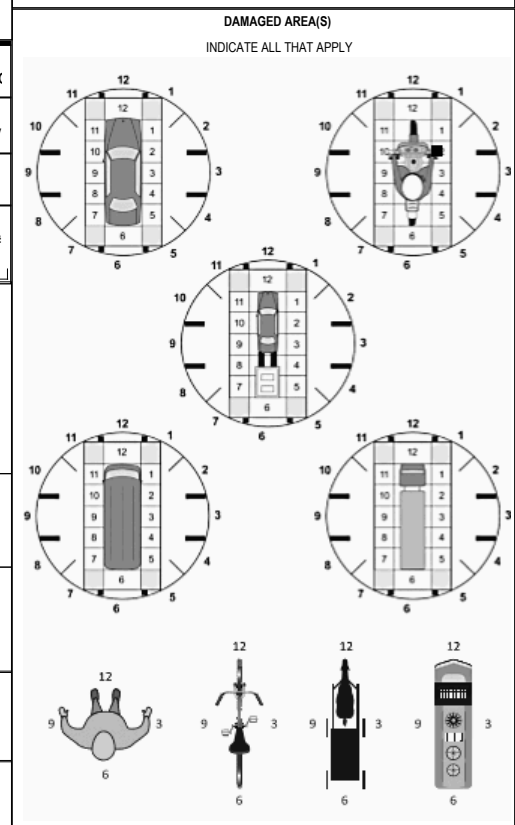
