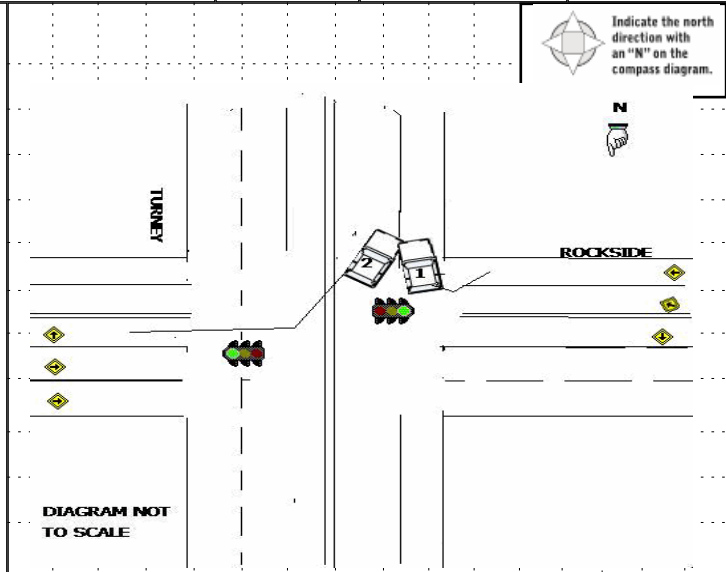

HE STATED HE HAD A GREEN ARROW AND TURNED LEFT ONTO TURNEY ROAD IN THE PASSING LANE WHEN UNIT #1 STRUCK HIS VEHICLE.

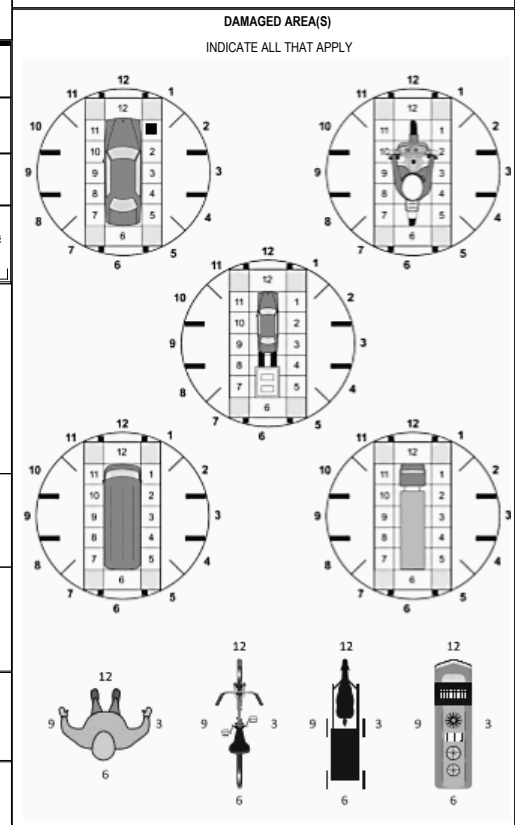
