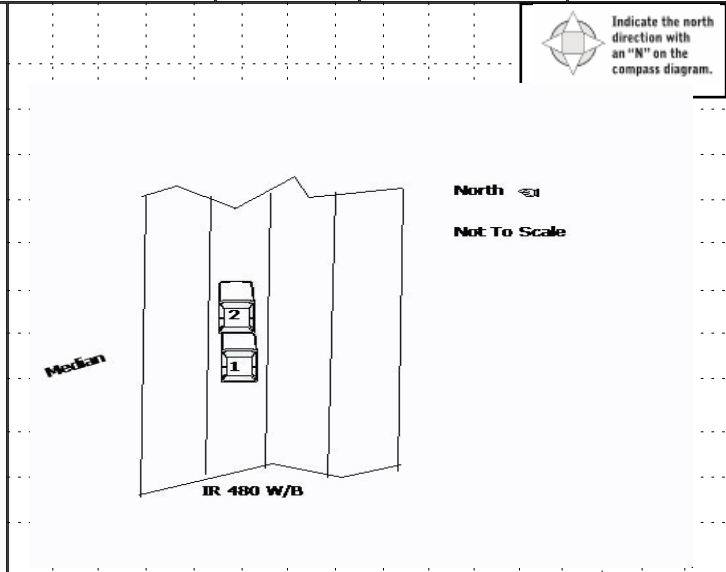

UNIT # 1 WAS TRAVELING EAST ON IR 480 NEAR MILE MARKER 21.6 IN THE MIDDLE INSIDE LANE. UNIT # 2 WAS TRAVELING EAST ON IR 480 NEAR MILE MARKER 21.6 IN THE MIDDLE INSIDE LANE AFTER CONTROL WAS REGAINED. UNIT # 2 LOST CONTROL AFTER HYDRO PLANING FROM THE INSIDE LANE. AS A RESULT, THE FRONT OF UNIT # 1 COLLIDED WITH THE REAR OF UNIT # 2. BOTH UNITS WERE MOVED FROM FINAL REST AND WERE PARKED IN THE INSIDE LANE FACING EAST NEAR MILE MARKER 21.6 UPON ARRIVAL.
