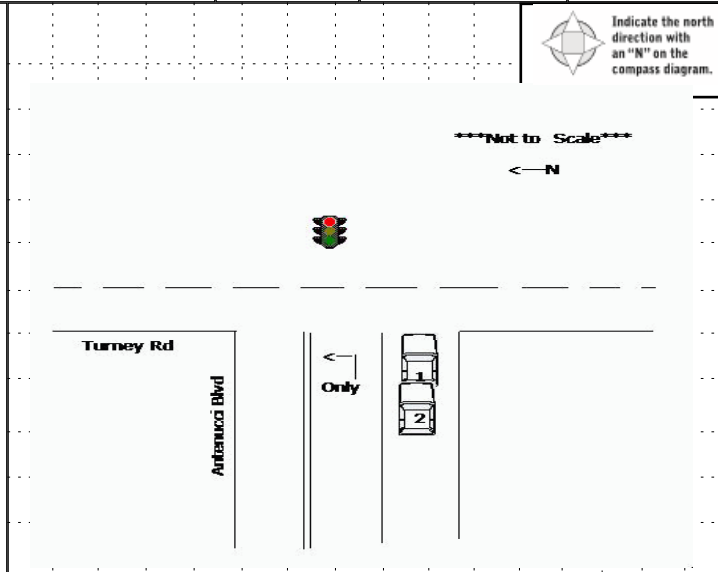

 DRIVER OF UNIT #1 STATED SHE WAS STOPPED FOR THE RED LIGHT IN THE CURB LANE ON ANTENUCCI BLVD E/B AT TURNEY ROAD. SHE ALSO STATED SHE PULLED FORWARD TO CHECK TRAFFIC IN ORDER TO TURN S/B ONTO TURNEY ROAD THEN STOPPED. WHEN SHE STOPPED, HER VEHICLE WAS STRUCK BY UNIT #2 WHICH WAS DIRECTLY BEHIND HER. ACCORDING TO HER, BOTH DRIVERS EXITED THEIR VEHICLES AND CHECKED FOR DAMAGE. SHE STATED BOTH DRIVERS SAW NO DAMAGE AND THEY ENTERED THEIR VEHICLES LEFT THE CRASH SCENE. SHE DESCRIBED THE OTHER DRIVER AS A 25 YOA
